2019 Reimbursement

Kerecis® Omega3 Wound is reimbursed in the high cost group for applications of skin substitutes in the HOPD and ASC settings using CPT codes 15271-15278. Medicare payment for Q4158 - Kerecis® Omega3 Wound is included in the payment for the application.

The Medicare national allowable rate for the high cost group in 2019 is \$797.53 in the ambulatory surgical center (site of service 24). Allowable for wounds larger than 100cm² is \$1424.22.
